

2027 Totalsports TWO OCEANS MARATHON

Vitality Gym benefit campaign

Terms and Conditions

Qualifying Vitality members who have purchased an entry to the 2027 *Totalsports TWO OCEANS MARATHON powered by BYD* race using their qualifying Discovery Bank product during the **exclusive pre-sale period (from 28 to 31 July 2026)**, can activate their Planet Fitness (Vitality Premium only) or Virgin Active (Vitality Premium or Vitality Active) Gym benefit (for a minimum 12-month membership at a local club) and pay **no activation fee**.

Definitions

 - 4.4. Discovery Account
5. Members must have an active Vitality membership (main member or spouse), either:
 - 5.1. Vitality Active, or
 - 5.2. Vitality Premium
6. Members must:

 - 6.2. Have a Discovery Bank account in good standing ([as defined here](#)).

11. This campaign is valid for in-club (in-person) activations or activations done through the Discovery app.
12. For this campaign period the Vitality Gym benefit activation fee, equal to one month's full retail rate of the gym contract, will be waived and the member will pay no activation fee.
13. Members must pay the gym access tag fee when joining Planet Fitness.
14. Vitality members (main or spouse) get up to 75% off their monthly local club gym membership fees. To maintain the maximum 75% discount on a local club membership, a member must visit the gym at least 36 times in a rolling 12-month period and exercise for 30+ minutes a day. Only one gym workout a day will count towards the requirements of your total 36 gym workouts.
